Text Response

I think that the title was misleading. It was too basic a session for me. Too much time spent on why study abroad is important -- we all know that.

Keynote should have more direct understanding/experience of the relationship between Univ. and State College. When sessions are used to present resources, do more than show the websites or invite participants to have digital technology there to enhance the experience of being "shown" web resources.

Dr. Brustein's situation, with 140 staff members under him all involved in some aspect of international education. was SOOO different from the circumstances of most of the participants that the presentation was close to irrelevant.

Text Response

The Service Learning and Undergraduate Research session should be split into two separate presentations. There were paralell topics, but the groups could have used more time, particularly the pair from Broward College on their service learning courses.

The Skyppe session was interesting as a new mode of delivery, but should make use of the potential interactive benefits rather than just provide the rehearsed powerpoint experience. Team presenters across the board made for more meaningful and effective sessions reaching a wider range of the participants and offering the opportunity for comparing strategies and techniques.

In session %A I wish Jennifer Robertson had had more time to discuss her work. Her materials were outstanding.

In the event that you host the event at the same location you can always partner with the Culinary Arts Program (if offered at your institution) to provide dinner at a lower or no cost, and m,ake it a project for the students in this program. Other than that just brown- bag it!

Cutting back on the dinner may be an option, but by the time we concluded, if anyone was looking for additional food, that would be rather late in the evening. If the option of heavy appetizers could be consumed as a light dinner, then I would suggest heavy appetizers and perhaps a salad bar.
