#### Text Response

It was great to have someone so prominent in the field, like Dr. Deardorff as the Plenary speaker and as a presenter. The safety panel was not helpful as they did not share any new information or innovative ideas or approaches to this area.

#### Text Response

For the sessions I attended, it would have been more helpful to have presenters sharing innovative and unique program models as opposed to sharing standard practices that are commonplace in most offices/universities.

Financial Aid should always have its own session (rather than a lunch panel) because the information is very detailed and difficult to follow in a panel format. Richard Colon is an amazing resource. A link to the resources and scholarships discussed in this session would be appreciated. I would have liked to have Jennifer Robertson presenting on best practices for study abroad. She should always have a session on this. She is a great model.

Regina Carvalho discussed specific steps her institution followed to expand their international student program. The presentation was clear and useful. Marcela VanOlphsen also gave a clear presentation of infusion of internationalism throughout the curriculum.

The contributions of Lasch and Kirsch were interesting and appeared to be helpful to many. Colon seems to say the same thing year after year. I would like to see more variety of topics in the sesions. Last year I believe that there were sessions on pedagogy and technology, etc. I would also like to see publishers and vendors with products relevant to the FCIE membership. Concurrent Session 4A came off more as a presentation of the program that they went on and not as a way to develop such programs which would have been so much better. Many of the questions that I had going into that session were not answered. Concurrent Session 5A would have been better if some of the ideas that were presented to us didn't have so many flaws. There were a number of compliance issues that needed to be addressed and in the defense of the presenter she didn't seem to be aware of some of them.

The classroom where I presented was way too cold, we had to leave the door open the whole time. Everything else was nice, good job:-)

I am very satisfied with the conference. The organization was flawless and seemed to run very smoothly (I would say effortlessly, if I did not know how much effort must have gone into it). I feel the food was more abundant in last year's conference, but the quality was very good. I was a little bit disheartened by the low attendance. What else could be done to spread the word? Thank you so much for making this meeting possible.

It was a great experience. Providing coffee on Thursday morning would have been nice. Need more coffee available all day!! :)

A bit of feedback on the hotel (not a criticism of the conference, but of the hotel itself) - We found it most difficult to deal with the tax exempt status of our College, even though we all were using College - issued travel credit cards that have our tax exempt id imprinted on them. The management was treating the matter as an inconvenience rather than a service to the guests. The food that was provided for breakfast was good for what it was, but had no healthy options whatsoever :0( The Networking Social was a really nice event - a minor feedback note - the food that was provided was delicious, but some of the food ran out far too quickly, and the late-comers did not have an opportunity to sample all that was offered. It was a very nice event overall, nonetheless!!!!!!

I thought the conference was very well organized and had a great range of sessions. I would recommend having coffee in the morning and offering veg options for lunch.

It would have been nice if the board members had split out a bit at the meals, etc. to get to know more of the membership.
